In **Thursday 's** trading session the following reflect the movement of the JSE Indices: -

- The JSE Index declined by 2,550.95 points (0.79 %) to close at 321,157.86.
- The JSE All Jamaican Composite Index declined by 3,601.74 points (0.98 %) to close at 362,231.27.
- The JSE Select Index declined by 88.57 points (1.11 %) to close at 7,872.37.
- The JSE Cross Listed Index advanced by 0.08 points (0.14 %) to close at 55.96.
- The JSE Financial Index declined by 0.43 points (0.57 %) to close at 75.20.
- The JSE Manufacturing & Distribution Index declined by 1.25 points (1.34 %) to close at 91.81.

Overall Market activity resulted from trading in **54** stocks of which **17** advanced, **30** declined and **7** traded firm.

Market volume amounted to *5,709,003* units valued at over *\$49,903,875.50*. *WIGTON WINDFARM LIMITED ORDINARY SHARES* was the volume leader with *1,406,226* units (*24.63%*) followed by *TRANSJAMAICAN HIGHWAY LIMITED* with *1,222,512* units (*21.41%*) and *SAGICOR SELECT FUNDS LIMITED - FINANCIAL* with *770,011* units (*13.49%*) .
